First Floor Plan

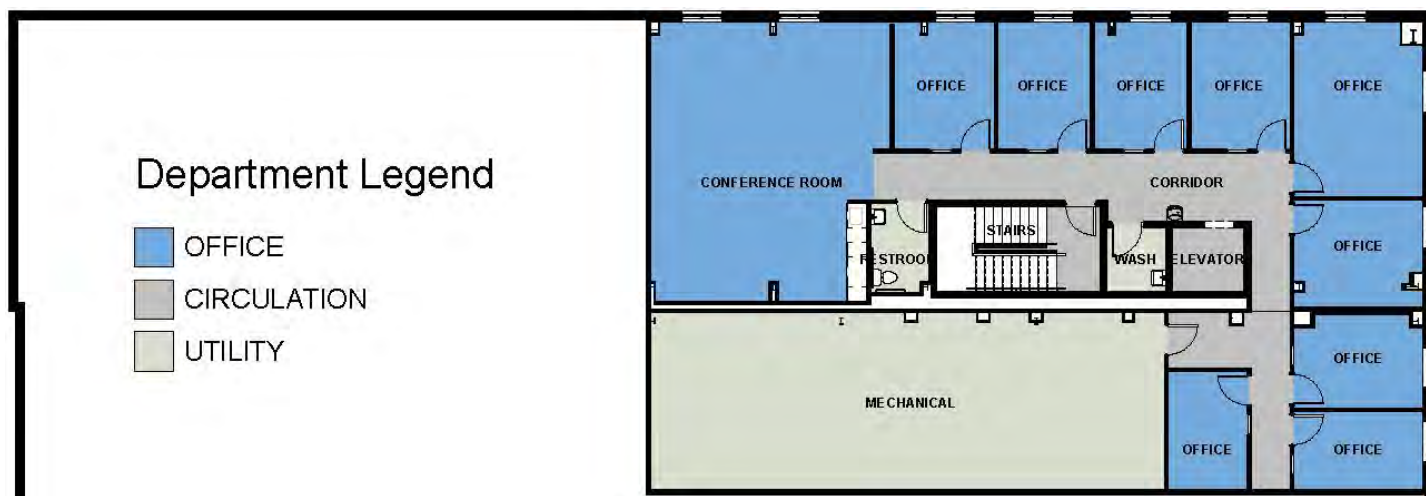

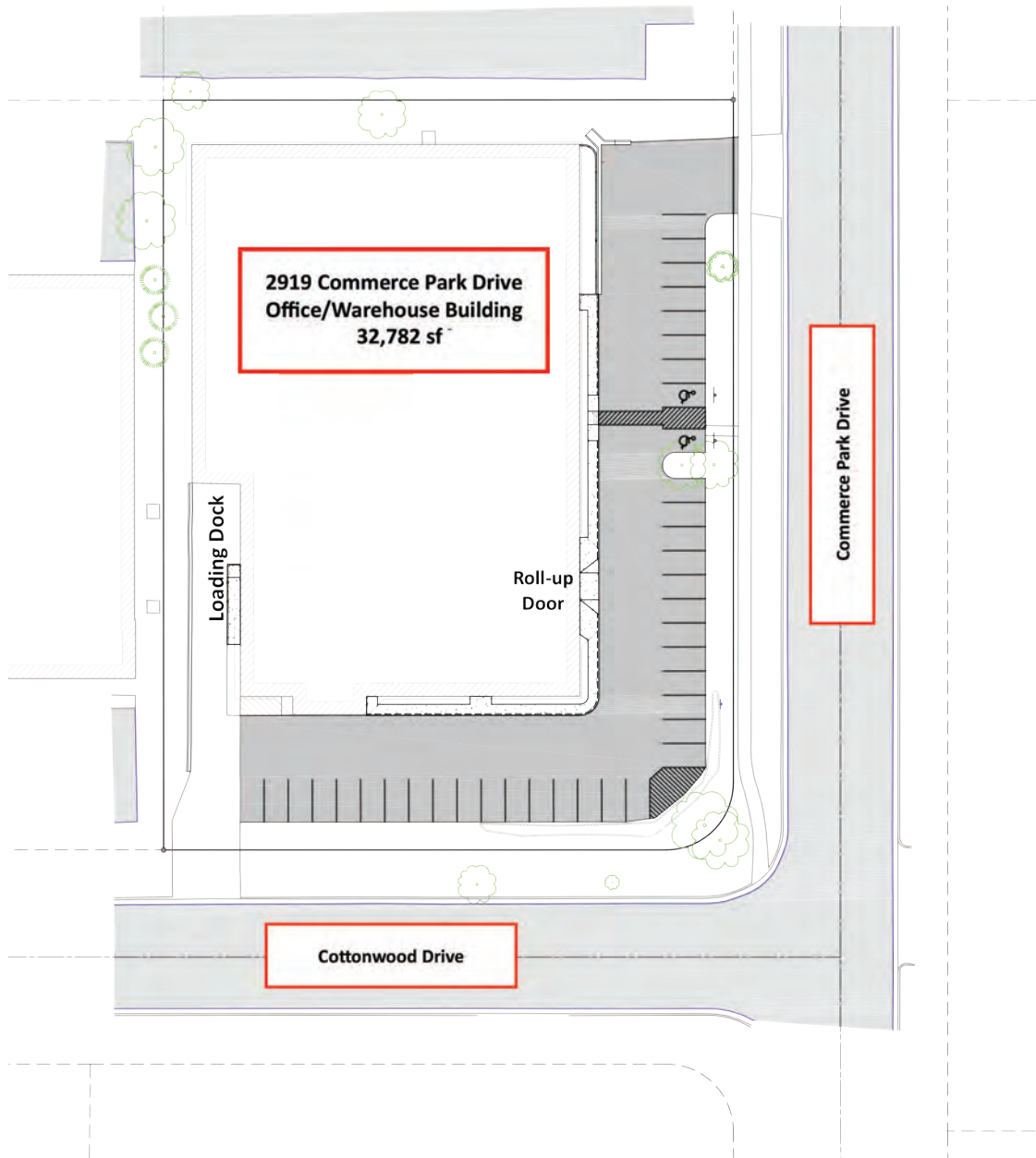
